This grant will enable us to support currently running programs within the Seward Boys & Girls Club with needed supplies and incentives. We run established, evidence-based programs to improve member's overall health, social- emotional wellness and academic performance. The Triple Play program is a whole-body approach to health which demonstrates how eating right, keeping fit and forming positive relationships add up to a healthy lifestyle. The opportunity to purchase supplies for our cooking units, new and stimulating games for our social recreation based Games Room and exciting sport-themed incentive prizes for our high-impact physical activities will boost participation among current members and help recruit new members to the Club.

Similarly, purchasing incentives and awards for our Power Hour program, which helps member's achieve academic success by providing homework help, tutoring and high-yield learning activities, will garner renewed excitement and help boost participation.

With 95 currently registered Club members and an average daily attendance of 41 youth, the benefits of these programs are far- reaching.

The goal will be increased attendance, participation, social emotional behaviors, homework completion and increase in grades. We hope to see less behavioral issues and cooperation among members. We will provide physical activities and challenges 5 days per week.

The program will benefit all 95 youth participating in our aftershool program. Through participation in our evidence-based programs including academic and enrichment activities, we expect to see an increase in self confidence, an increase in behaviors among youth, increased engagement in Club and school through our Power Hour homework program, an increased knowledge of healthy habits including food choices and preparation and physical fitness. Parents and teachers at the elementary will benefit as youth will have the opportunity to participate in activities to improve their attention span, help regulate self control and outbursts in a structured setting, continue learning beyond the school day and the opportunity to have homework completed at the Club removing that stress from the family.

Daily participation is tracked through attendance records as well as various incentive programs. Youth will participate in the National Youth Outcomes Initiative, a mandatory student / member survey completed annually created by our national organization, Boys & Girls Clubs of America. This survey is a tool that gives members the opportunity to anonymously rate their experience at the Club including safety, academics, relationships with staff, participation in activities, etc. Our Home Run Derby board tracks member's participation in the daily high-impact physical fitness games and activities. Members are awarded 'bases' for each day of participation as they move around the baseball diamond and prizes for each 'home run.' Members are also tracked for Power Hour, receiving a point for each day of participation and awarded prizes for reaching milestones.

In our community there are children with a wide range of oral aversion. This ranges from the mild side where a child self-limits the number of food items they are willing to eat to the point they are at risk of malnutrition to the severe side where a child refuses to allow any food near them and will starve themselves before eating. This is usually caused by a trauma of some kind. It can range from a traumatic event that happened in the home such as abuse to medical trauma caused by lifesaving interventions in the NICU such as being on a ventilator multiple times early in life. Once a child has developed oral aversion it can be challenging to overcome. Often a feeding tube is placed in the child's nose or a feeding button is surgically placed in the child's abdomen to get necessary calories in the child to sustain life. In the Seward community there are children on both ends of the spectrum. There are no resources in the Seward community to help parents overcome oral aversion. The current recommendation is to take the child outside to a hospital based specialty feeding clinic. This requires the parent and child to go out of state for 8-12 weeks for treatment leaving the rest of the family behind. For most families this is not possible due to other obligations such as work or other children in school or simply the cost of making such an extended trip. In addition uprooting the child from his natural environment and splitting the family up is an additional trauma itself.

There is and will be continued collaboration with the Seward Infant Learning Program as they have children in need of help with feeding issues currently in our community as well as developing a collaborative relationship with the new pediatrician Dr. Roloff.

Jeanie Glenn will attend the Star Institute for Sensory Processing Disorder SOS Approach to Feeding Conference and bring the information back to the Seward community to help with children in the community who have oral aversion. Working with the families to help them develop plans for working thru their child's oral aversion including individual child based strategies specific to each family.

Jeanie Glenn will be better able to act in the capacity of a family navigator in collaboration with the Seward Infant Learning program to help those families in our community whose children experience feeding issues. This will provide an educational resource for parents within our community whose children experience oral aversion. This will also allow Jeanie Glenn to take more advanced feeding courses online thru the Star Institute for Sensory Processing Disorder to increase the resource available. Because this is a rare disorder there will be 1 to 2 children yearly whose families need this help. Currently there are two children in need of this help in the Seward community including Jeanie's 3 year old son John who is 100% tube fed due to medical trauma in the NICU.

Seward Prevention Coalition (SPC) was established in 2005 by a small group of like-minded community members interested in collectively addressing community-wide change in regards to behavioral health issues. Since inception, the coalition has grown from the original 10 members to 75 members representing over 40 different groups, businesses, and organizations within the Seward area. For the first 10 years the coalition had a fiscal agent, but in 2015 began the process of establishing ourselves as our own 501c3, which allowed the coalition to take over our state grant in 2016 and expand as an organization. With the formation of our own 501c3 non-profit status, we have grown even more and it has allowed us to support other programs and projects for the community of Seward. Since 2016 SPC as grown from one primary focus area with one staff member, to 8+ areas of focus and five staff members under our umbrella.

Our primary focus is always prevention work to effect change in regards to health issues within the community. Current projects and programs we are supporting include Underage Drinking, Adverse Childhood Experiences, Diabetes Prevention, Mindfulness & Meditation, Seward Strong, and Sources of Strength. Beyond these programs we are also working to support the re-establishment of Parents as Teachers, to bring mindfulness practices to our elementary school classrooms, supporting the newly formed Seward Ice Rink Group and the Sustainable Seward Group that were selected as this year's initiatives from Seward Strong. We also continue to act as the fiscal agent for the Garden By the Bay group.

Since one of our primary goals as an organization is to promote the collaboration of groups to share resources and tackle like-minded issues, SPC tries to partner on events and programs as often as possible. We also encourage our members to partner and share resources when they are able. This intentional approach allows for more successful events and greater opportunities for our community. Some of the events and programs we have partnered on this past year include the Qutekcak Healthy Lifestyles Picnic, Opioid Epidemic Panel Discussion, Trauma 101 community webinar, Resilience Movie, Archery at the schools,

Sustainable Seward, a new grassroots organization, is seeking support to host an electronics recycling event in Seward on May 12, 2018.

Seward Wellness for All, a branch of the Seward Prevention Coalition, held its second annual Seward Strong Planning Day on December 5, 2017. At this all-day event, community members came together to brainstorm and then select two initiatives to improve the health and wellness of the Seward community. One of those selected initiatives is now branded as Sustainable Seward and has as key goals to encourage waste reduction, reuse, and recycling in the Seward area.

The group immediately set to work, holding monthly meetings since December. Large group meeting attendance has averaged about twenty, and three working subgroups have formed to develop specific goals and projects, including Business Impacts, Education & Perception, and Plastic Bag Reduction.

One goal of the Business Impacts group is to host an electronics recycling event in Seward. Currently, Seward residents and businesses must haul electronics to Anchorage for recycling. This distance, cost, and limited hours for drop-off can be a real hindrance to proper disposal of electronics. Electronics contain toxic substances such as lead, mercury, cadmium, chromium, and other heavy metals hazardous to the environment and humans. If not processed properly those chemicals can seep into water supplies and endanger humans and wildlife nearby. Additionally, recovering high-value metals such as copper, aluminum, gold, and silver from old electronics conserves natural resources. We believe most residents and businesses of Seward and Moose Pass want to do the right thing with their old electronics, but in many cases, they do not have the resources to do so.

Our nonprofit partner is Cook Inletkeeper, who has managed an electronics recycling program in Homer since 2006. In recent years, Cook Inletkeeper expanded the footprint of their electronics recycling program to Soldotna (2017), Cooper Landing (2018), and Ninilchik (2018). Cook Inletkeeper has established advertising, protocols, and transportation and disposal partners for the event, and we will be able to draw on their experience and expertise.

The Spenard Builders Supply (SBS) store in Homer has long hosted the Homer electronics recycling collection, and the Seward SBS store manager, Michael Grzembski, has agreed to host the Seward event.

The event will be held on Saturday, May 12, which also is Super Saturday Cleanup Day in Seward. Cook Inletkeeper's other e-recycling events in the western and central Kenai Peninsula are planned for May 5, which will allow their staff and volunteers to come to Seward for our event to assist in our first year. Having these events on successive weekends will also assist in joint advertising and promotion of Seward's first electronics recycling event.

Project/Program Goals*

Goal #1: Volume of electronics collected

At the first Seward electronics recycling event, we hope to collect at least 10,000 pounds of recyclable electronics, similar to what was collected in Homer in the first few years of the program. Currently, Homer collects over 20,000 pounds annually.

Goal #2: Community education

We plan to use the event to communicate the importance of proper disposal of electronics to individuals and businesses in the Seward and Moose Pass communities. Facebook posts, events, and advertising will be used to communicate both the details and logistics of the event as well as why it is important to the health of people and the environment. In addition, we will ask local media (radio, Seward Journal, Seward City News) to cover the event.

Goal #3: A tangible product of Seward Strong

The timing of this event will create an opportunity to be a tangible and visible success of the Seward Strong program. While Sustainable Seward's project planning is still in the early stages, we expect to be able to share other initiatives with participants at the electronics recycling event and build more momentum in the community for waste reduction and recycling. For instance, we are exploring the possibility of a community-wide reusable shopping bag. If we are successful in producing a reusable shopping bag by early May, we may provide a free bag to each person participating in the electronics recycling event.

The entire community of Seward will benefit from having access to convenient electronics recycling. In addition, we will actively reach out to other nonprofits based in Seward and Moose Pass to encourage them to participate in recycling and/or by providing volunteers.
