We are proposing to bring Ghanaian musician and cultural ambassador Okaidja Afroso to Seward for a week in November to conduct an artist residency at Seward Elementary School. This residency will expose every student at Seward Elementary to Ghanaian culture, with an emphasis on music, rhythm, and dance. All classes will get at least one hands-on lesson period with Okaidja. Additionally, two grade levels will work more intensively with Okaidja throughout the week, working toward a performance on Friday during an all-school assembly featuring Okaidja and the students. In addition to this intensive residency at Seward Elementary, Okaidja will provide a single workshop for the high school, as well as an evening workshop open to the public. Finally, he will perform an evening concert in the community as well.

We are collaborating with Seward Elementary School, the Seward Music Association, and the Seward Arts Council to pursue this workshop. The music program at the Seward Schools is greatly reduced from what it once was, with a single teacher serving the elementary and middle school. At the High School, there is only a loosely organized music program that meets once a week during non-classroom hours. This residency will help expose students to professional-level performing arts and music, as well as giving them a unique exposure to African culture.

The goals are to:

Provide students with hands-on music and rhythm experiences Provide students with exposure to a foreign culture, the culture of Ghana Provide community members with an opportunity for a unique percussion workshop Provide a performance for the Seward Elementary School students which will include some of their peers Provide a professional evening concert in Seward

At Seward Elementary school, more than 200 students will have direct, hands-on interaction with the artist. Approximately 70 of those students will have a more intensive interaction with the artist, resulting in a performance, which provides them invaluable stage experience in front of their peers. An unspecified number of people will have the opportunity to learn rhythm from a professional musician at a public workshop, which could potentially lead to ongoing drum circles or other connections between community members. When a community dances, sings, and drums together, how can that not be a positive?

Exposure to arts education sharpens critical thinking skills, improves attendance, and promotes self-directed learning. As of now, there is no established art program at the elementary school level. Art instruction is implemented by

general education instructors at their discretion and as time allows. A structured art program would benefit the community by fostering critical thinking skills in our young learners and easing the transition to upper grades. They will be more suited to cultivate a personal practice or deepen their study of arts in the future. Students who have meaningful connections to their art practice gain confidence through self-expression and may become more engaged in other aspects of the Seward community and our schools.
