- A. Call to Order 6:03 PM
- B. Approve Agenda Ryan moved to approve the agenda as presented. Phyllis seconded the motion. PASSED.
- C. Mission Connect To validate a previous vote held by email, Ryan moved to approve Tekla Seavey as a new SCF Advisor. Robbie seconded the motion. PASSED. Amy reminded everyone of the web based training on the new Community Suites software program at noon tomorrow (Thursday, October 17). She has sent everyone a link to connect. It will also be posted afterwards for those who want to watch later. The training is open to all advisors. The board will decide at a later date which advisors will have access to the donor data.
- D. Business Session
 - Approve September 18, 2019 minutes Robbie moved to approve the August 21, 2019 minutes as written. Ryan seconded the motion. PASSED.
 - Donations/Treasurer's Report—Melody: See written report provided.
 Melody will be gone in November. Patty will check the mail and cover for her.
 Melody is not sure if ACF or SCF is supposed to pay the bill from the Foraker
 Group for the Brown Bag Lunch Training. Amy will contact ACF and find out.
 If SCF is supposed to pay the bill Phyllis and Robbie approved Melody making the \$611.68 payment by SCF Credit Card.
 - Team Reports

- I. Grant Team Update—Patty
 - a. Mini grants
 - Iron Mountain FFA The group has raised a lot of their own funds for this trip. It was noted that they will repay the school for the airfare so it is not necessary for the funds to be available immediately. After discussion Robbie moved to approve \$1000 for this mini-grant. Melody seconded the motion. PASSED.
 - ASLC Holiday Party This has become a popular event and start for the Holiday season in Seward. After discussion Robbie moved to approve \$1000 for this mini-grant. Phyllis seconded the motion. PASSED. SCF should be sure ASLC has a large SCF Banner to display at the event. (Who?)
 - 3. ASLC Small Fry School The board thinks this is a valuable program that teaches stewardship for the environment at a young age. It also helps fill a gap in early childhood education that exists in Seward and will get worse after the closing of Big Bay Beginnings Pre-school at the end of October. After discussion Phyllis moved to approve \$1000 for this minigrant. Ryan seconded the motion. PASSED.
 - 4. Seward Sonics MS Basketball League Amy provided some background on this program after a few advisors said they had a hard time finding any information. The program is open to any middle school student and expects to grow. It is an incentive for students to do well in school and provides structure and discipline that may otherwise be missing. It will not conflict with any existing Middle School basketball programs. After discussion Ryan moved to approve \$950 for this mini-grant. Robbie seconded the motion. PASSED.
 - b. Lowell Point Fire Department Amy informed the board that she had received a call from the Fire Chief of the Lowell Point Fire Department. They were awarded a \$1700 grant for new equipment a few years ago and ACF has been asking for a grant report. The problem is that the Lowell Point Fird Department never received the funds. Bear Creek Fire Department non-profit was the fiscal agent for the grant. Bear Creek had a change in administration and never gave the funds to Lowell Point. Now that they are aware of the situation ACF will take care of this.
 - c. ACF Basic needs grant Amy reported that ACF would like a list of potential grant recipients. SCF can award the entire \$5000 to one group or split between two or more. The board discussed several options for recipients of this grant and determined our top three choices right now: Seward Senior Center transportation and food programs, the Seward Ministerial Association medications program and Independent Living Center taxi voucher program. Melody will contact the Seward Food Bank to learn what their current needs are. Patty is concerned about the lack of preschool and licensed daycare programs in Seward but it was decided that this situation requires more study and would not be a good fit for these funds.
 - d. 2020 Grant Cycle Amy reported that SCF will find out at the end of December how much we will have to grant in 2020. The 2020 major grant cycle for SCF will run from January 15 – February 21. The January grant amount announcement and non-profit gathering is tentatively scheduled as a luncheon January 22 at the Breeze Inn. Current plans are to have a format similar to our Brown Bag gatherings, with a discussion on how to run an

efficient board meeting. Possible speakers include Cindy Ecklund or Christie Terry.

- II. Executive Team Kim: ACF has formally defined the roles and duties of ACF, Affiliates and Program Managers. This document was included in the October Board Packet.
- III. Fundraising/Development Team
 - a. Robbie reported that the "Friendraiser" event on the M/V Dutch Harbor in September went very well. The venue was excellent. The food and beverages were good. The only disappointment was that only eight of the 20 people invited were able to come. This may have allowed more valuable conversations with those who did attend. There were many good questions asked and answered during the event. At least one person expressed an interest in joining the SCF advisory board. Al and his crew are open to more events on the ship. Advisory board members should consider doing another "Friendraiser" event this winter,
 - b. Legacy Giving ACF has offered \$500 toward funding a Legacy Giving training or event. This will be discussed at the January meeting.
- IV. Community Outreach Team Ryan: The winter newsletter is being put together.
- V. Program Manager Report Amy: See written report sent with board packet.
 - There was a discussion at a previous meeting about possibly having more than one major grant cycle per year. Amy reported that ACF will allow no more than two grant cycles per year. SCF currently has our major grant cycle and the mini-grant cycle, so we cannot add another one. Advisors agreed we like the two Grant Cycles we currently have.
 - Amy received a call from a donor who was concerned about the grant SCF awarded to the Seward PRIDE group. It illustrates the need for more discussion, planning and training in Diversity, Equity and Inclusion.
 - Advisors can still reach out to local businesses to ask for donations to the SCF Operating Endowment.
 - Amy requests SCF send personalized newsletters to top donors and donors who have their own funds with details about how earnings from their donations have been used. (Donor Development Team)
 - Amy reminded advisors about the training available at noon tomorrow (Thursday, October 17) on the new donor software.
 - The amount of the Basic Needs Grant may be changed. ACF has solicited donations from businesses for this grant so the amount may increase.
 - Amy still needs bios from Robbie, Ginger and Tekla, and photos of Ginger and Tekla.
 - Amy confirmed team assignments and will correct the list of SCF Team members which was sent with the October board packet.
- E. Calendar/Holiday gathering Melody has offered her home for the Holiday gathering of current and past SCF Advisors and spouses. Her address is 1133 Cliff View Place. The date is Sunday, December 8 at 6 pm. Dinner will be potluck. There will also be a White Elephant gift exchange. Please RSVP to Melody. Amy will send out Greenvelope invitations.
- F. National Philanthropy Day is November 25. This would be a good time to send personalized thank you letters to donors and fund holders. This will be discussed at the November meeting.

- G. Giving Tuesday Robbie is the lead for Giving Tuesday, which is December 3. He would like to have SCF Advisors at several local coffee shops with literature and donation envelopes. ACF may have a media packet for the event. More details will be firmed up at the November meeting.

Our project is the collection and disposal of three recycling commodities, aluminum cans, glass beverage containers and corrugated cardboard in the downtown Seward area. Money from this grant would be used for the cost of emptying this recycling collection roll off container. Each time the container needs emptying it costs \$150.

This project has only been in existence since July 3rd, 2019. We have had the recycling container emptied twice, taking. approx. 3-4 weeks to fill up.

Through collaboration with the Kenai Peninsula Borough Solid Waste department we were able to obtain a four compartment recycling collection roll off container at no cost to our organization. The value of this unit over \$10,000. We paid the transportation cost to bring it from Soldotna to Seward, \$600.

Through collaboration with the National Park Service, Kenai Fjords National Park we have a location on their property for the recycling container. It is conventionally located in the alley between 3rd and 4th avenues, just north of Washington Ave. Value of this location in unknown, but priceless to us.

Recycling is good for the community because it reduces litter when people realize there's a value in that empty bottle or can. Recycling is good for the community because it's reduces our amount of trash that fills our landfills. By extending the landfill's life we reduce the number or acres of landfill we need to have.

Our goals would be to reduce by 30% the volume of garbage put into the waste stream by the downtown area and increase the volume of recyclables sent to Anchorage from Seward by 50%.

With this central location to most of the downtown bars and restaurants we are hoping to capture much of the aluminum, glass and cardboard from businesses near by. Recycling these items will greatly reduce the volume of inert garage going into the landfill cells. Also the aluminum is a marketable commodity. Aluminum can be recycled into new products numerous times. Corrugated cardboard can be made into new products several times. Glass bottles are just a bulky, inert object that will last forever in a landfill and can be used for other purposes, including but not limited to, adding to asphalt, as fill, instead of gravel.

The Kenai Peninsula Borough spends large amounts of money to build lined cells for our garage to be placed in. These lined cells are required for landfills now. All garbage from Seward gets hauled to Soldotna and the Central Peninsula landfill. By reducing our volume from Seward, we not only save space in the expensive lined cells, we reduce transportation costs, and contribute less exhaust and emissions to the air. Lower transportation costs could eventually reduce our trash collection rates in the Seward area.

Recycling reduces air and water pollution, both which could impact our beautiful town and ocean. Trash and litter detract from the beauty of our tourist town, impacting the businesses that rely on tourists. The more we recycle the less new materials we need to manufacture, the less new raw materials we need to cut down or mine.

Press releases we're hand delivered to all downtown restaurants, bars and many stores in early July. We are currently in the process of having meetings with restaurant, bar, and shop owners/managers to encourage them to participate in our project and offer any assistances to them in setting up a recycling program in their businesses. By reducing their waste removal costs businesses can save money, spending it elsewhere, like donating to local non profits.

We will measure our success by the volume of garbage hauled to Soldotna and volume of recyclables hauled to Anchorage. These numbers are easily obtained from the Solid Waste department at the Kenai Peninsula Borough. We will continue to use social media and local news outlets to report our successes and struggles and educate the public on how they can help us.

Our hope is to have this container stay in the downtown area for perpetuity. We will be asking local businesses that are utilizing it to donate to the cost of emptying it. If most businesses utilizing the recycling container donate once per year we will have our costs covered. We may also apply for other grants to cover the costs as needed. One way or another we will raise the money to have it emptied as needed. A downtown

recycling collection site has been a goal of our group since the beginning. We are proud that within 19 months of our inception we have reached this goal and are started collecting recyclables downtown.

This grant money would be used to have the recycling container emptied while we collect donations from local businesses.

Steve Fink and myself, Mica Van Buskirk, began the robotics club this year and we are coaching six middle school aged students through the First Tech Challenge program through FIRST. We have met 2-3 times a week since late August with the team to make this happen. This is the first year there has been this program available to students in Seward. In this challenge, the students will design and build a robot from scratch, program it to perform specific functions and work together with another team to score points and win the game. I have coached a First Lego League for two years in Seward and our team has qualified to go to the State Finals each year. Several of these team members were ready to move onto the next level which is First Tech Challenge. Steve Fink agreed to assist with coaching since this level of robotics requires engineering and programming expertise that I do not have.

Our team is part of the Southcentral League where 19 other FTC teams across Southcentral Alaska will compete in 3 separate scrimmages in November in Palmer, Anchorage and Wasilla. In December there is a Statewide Qualifier of 40+ teams which will determine which teams advance to the State Finals in February. From there, a few teams move on to compete in a Worldwide competition in April.

Our goal for our first year is to design and build a robot to perform as many of the operations as possible in the challenge, begin learning Java programming enough to be able to program these operations, create a strategy to earn as many points as possible and keep a detailed engineering notebook to be able to present our design and engineering process to judges at the competitions. These students will also be performing outreach to younger FIRST teams in the Seward/Moose Pass area and also to the community to increase awareness and inspire more kids to join this program next year.

- Soft Tiles for Field - These soft tiles are made of the same material that will be used in the final playing field, we needed a set of them for practicing

- Mecanum Wheel Kit - These specially designed wheels allow greater control and maneuverability of the robot during the game and the kids were very excited to use them

- Tetrix Structure Pack - This structure pack included structural items the team determined they would need to build a solid foundation

- Control Hub - Our team applied for a grant to pilot a program where this new control hub would be used on this years robots. We were awarded the \$175 grant but the hub cost \$300

- Linear Motion Kit, Battery Pack, Sensors, Hex Motors and Misc - The team's robot design required the use of this linear motion kit to be able to pick up the blocks and move them. We ordered an extra battery pack so we would always have a fully charged battery. Sensors are also necessary for their design. The Mecanum wheel kit required two additional hex motors to operate. Fasteners and bearings were also needed.

- Team Sweatshirts - The team designed their team sweatshirt to demonstrate their team spirit at the competitions

- Meet Registration Fees - We will be travelling to 4 different competitions in Anchorage, Palmer and Wasilla. Each one requires a \$50 registration fee to cover expenses.

- Hotel Fees - Two of the competitions will be two day competitions held in Anchorage and Wasilla and will require the team to stay in a hotel each time. We have budgeted \$195 per room for three rooms for each competition.

- Team Dinner - The two competitions that require an overnight stay in Anchorage and Wasilla, we would like to be able to have a team dinner where we can all eat together

- AVTEC donated a room for our team to meet regularly and set up our robot playing field

- Seward PTA provided us with insurance for our team so we could meet at AVTEC

- Seward High School has allowed our team members to use their 3D printers to print game elements the team has designed

- Steve and I have donated over 120 hours each working with our team as they progress through the challenge $% \mathcal{A}^{(1)}$

Travel and competition fees are the only team expenses that we have not already expended to make this possible this year and if we can get some of these expenses covered, it will reduce the amount of personal investment that Steve and I have made to make this happen this year.

We had for several years used the high school music room at no cost however beginning in 2018 the Kenai Peninsula Borough required payment from all entities. This year the rent went up to \$20 (from \$15) per hour. Our group does not charge dues or generate revenue because our concerts are put on at no cost to the public. Our request from your foundation is for funds to pay the high school for use of the Music Room as well as Auditorium costs for up to 2 concerts. Additionally, we would like to request any funds not spent on rent to be authorized to purchase music for the community band for future concerts. This is subject to our ability to perform more than one concert this season.
