Seward Community Band

The Seward Arts Council recently received a \$1,000 mini-grant to support the Seward Community Band in bringing quality music to the community. The grant aimed to provide a stipend for the band's conductor and fund new musical selections and folders for the members. Under the leadership of CJ Levine, who stepped in as the conductor due to the band's significant growth, the community band has doubled in size to 28 enthusiastic members. Although the \$400 per concert stipend is modest compared to other orchestras, it serves as compensation for Levine's time.

With the grant, the band was able to purchase new folders and select exciting pieces for future concerts. Winning selections include scores from Mary Poppins, Wellerman (featuring Aussie folk songs), and a unique musical score highlighting each planet in the solar system. Kim Kawalski-Rogers, representing the band, is confident that audiences will appreciate these engaging and enjoyable musical pieces. The community band consists of individuals who genuinely enjoy coming together to create music, with about half of its members affiliated with the SeaLife Center. The band's talent is evident in their high-quality performances at recent concerts. Those eager for more can catch a portion of the Seward Community Band playing at their Fall concert, to be scheduled soon. 


Hello, I'm that dollar you just donated to Seward Community Foundation. Firsties, thank you very much. I've got to say! I much prefer this to being exchanged for a latte. Perhaps you'd like to see what happens to me now that I am part of SCF...well, here's my journey.

My first stop is in the unrestricted grant-making fund, or one of the many funds that generous donors have set up to support causes close to their hearts. In any case, that is where I will call home forever. That's when the good folk of The Alaska Community Foundation puts me into a range of investments. This way, I can grow and make more dollars just like me.



Take a look at what has happened since the beginning of the Seward Community
Foundation. This graph shows the growth from donations. See the big jump? That
was the generous legacy gift from Tony Rollo. Two things he truly loved, ice cream and Seward!
These donations are invested, and this investment growth is used to fund local programs and projects.



To determine how much money is available for grants, a spending policy considers a 5-year average in investment return and a 5-year average fund balance. This method protects the fund balance ensuring donations are never spent, only the interest. The interest dollars go to charitable organizations in Seward and Moose Pass that support music, education, sports, the unhoused, cultural awareness, social services, emergency services, beautification projects, preservation of historical archives, community health, library needs, and a ton of other good works.

Take a look, this is how through the years, based on growth and donations, SCF has been able to provide grants to local organizations. A total of nearly one and a half million dollars has been granted. But, the best part? I'm still here, right where I started. And that's where I'll remain nestled in the fund that you chose. And I will continue to grow and provide services to people far into the future. So, for those folks yet to be born, thank you for your dollar, which will help so many. Although the major grant cycle has concluded for 2023, remember that mini-grant opportunities are available year-round.

Mini-grants of up to \$1,000 are a flexible funding opportunity that may support a broad range of community needs throughout the year. Mini-grant applications are evaluated monthly.

Grants must be submitted by 5:00 pm on the 5th of each month to be considered during that month's advisory board meeting. Decisions are announced during the 3rd week of the month. Strong applications are those that demonstrate other sources of support and have measurable outcomes. For more information, visit sewardcf.org/grants.

A \$4,250 grant was awarded to Seward Little League to help purchase uniforms, bats, and a new practice mound to support their thriving league. Since its founding, Seward has had a strong affinity for baseball both in the adult and youth leagues. SCF is proud to highlight the good works of the many volunteers of the Seward Little League and their continued contribution to Seward youth.



SCF recently talked with Chris Thompson, President of the Seward Little League. Currently, the league comprises boys and girls aged four to thirteen years old. In recent years, the program has seen increased interest and growth that Chris credits to former president Drew Barlow. Last year, the league involved a record 113 players. Thompson says, "One of the great things about this sport is that it is inclusive with boys and girls participating." Critical to the program's success are the volunteers that make up the program's backbone. In addition to coaching the teams, volunteers fill in as referees, field maintenance, base coaches, concession operators, scorekeepers, and many other critical roles; without volunteers there wouldn't be a little league.

Last summer, twelve players in the Intermediate League (II-I3 year olds) surprised everyone by fighting their way through the ranks during the State All-Stars competition. The team found themselves in the championship game but lost it in a nail-biter to an Anchorage team. There are hopes to expand youth baseball opportunities by adding a Seniors League for players up to sixteen years old. After graduation, Fischer plans to get his 100-ton license through AVTEC. Well done, Fischer!




Mt. Marathon Raffle Record
